

SUMMARY ANNUAL REPORT

For Affirm, Inc. Welfare Benefits Plan

This is a summary of the annual report of the Affirm, Inc. Welfare Benefits Plan, EIN 45-5413534, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., National Union Fire Insurance Company of Pittsburgh, PA, Prudential Insurance Company of America, Lyra Health, Inc., Arag Insurance Company, Four Ever Life Insurance Company, Hawaii Medical Service Association, and One Medical to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Legal, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$4,022,452.
